Our Coalition Work This Summer

WSLC Convention

I was one of four AFT Washington delegates to the Washington State Labor Council this summer. It was a very active and engaged event, meeting in-person again after a virtual session in 2020. Our team was successful in passing the AFT Washington Resolution on CTC Workforce Pay. We learned a lot about co-sponsoring and lining up resolution supporters, with some help from our friend David Loud, representing our ally, Puget Sound Advocates for Retirement Action. David and I introduced the 2022 Healthcare Resolution, which also passed. In the aftermath of the Supreme Court's Dobbs decision overturning Roe v Wade, Washington Labor took a bold and courageous stand on reproductive rights.

Health Care Is a Human Right

As the Washington Universal Healthcare Commission heads toward its first-year report (due in November) Health Care is a Human Right leads the coalition in pushing for meaningful progress. Passage of a state-based universal healthcare bill in Congress is vital to obtain the federal waivers that Washington, California, Massachusetts, and New York need to lead the way from the state level.

Public comment at another Washington state commission, the Healthcare Transparency Board, was largely from the industry side until HCHR got coalition members to show up. We're pushing for more patient membership on the board.

The MLK Labor Council will kick off the Labor dialog called for in the Healthcare Resolution we co-sponsored at the WSLC Convention with a personal presentation by Rep. Pramila Jayapal at the October membership meeting.

PEBB Coalition

When the Healthcare Authority planned to drop the popular PEBB Traditional Medicare option for retired Public Employees, HCHR and others got hundreds of people to show up at a Healthcare Authority (HCA) zoom, delaying the decision for a year and obtaining feedback from stakeholders. The Retired Public Employees Council is leading a coalition to provide this feedback, and I've been asked to represent AFT Washington at these HCA meetings. This is another battle in

our fight against the privatization of Medicare.

Support for Plan 1 COLA

Another WSLC Resolution, which we supported, highlighted how far behind our oldest state retirees have fallen due to dropped COLAs and inflation. We co-signed a letter with a coalition of retiree groups, and this will be a legislative priority for AFT Washington in the coming session.

Inflation Reduction Act

We celebrate the climate, tax and healthcare provisions in the Inflation Reduction Act, but expect more work to be necessary to expand Medicare benefits and the drug prices impacted.

It's been a busy summer for working in coalitions.





AFTerburners Update for September 2022

The AFT National Program of Retirees formed the AFTerburners group during 2020 to make virtual phone calls to encourage union members to register and get out to vote. We were able to support national, state, and local elections and legislative efforts, and to make wellness calls during the height of the pandemic.

Our outreach efforts via phone banking have continued to include building and supporting locals and chapters throughout the U.S. Several AFTerburners volunteered to help the AFT Washington Retiree Chapter with our 2021 membership drive.

The pie chart shows the results of phone calls made from January to August 2022 covering topics ranging from voter registration and general federal legislation to limited issues, such as gun violence legislation. The 6,776 phone attempts sometimes can include left-messages, and the 519 conversations indicate more time spent with an individual, for example, guiding someone in how to access an online voter registration site. As you can see, we're working on a lot of critical issues, and with less than 60 days to go before the election, we're ramping up efforts.
