The Committee On Political Education

The Committee on Political Education, or COPE, is the political arm of AFT Washington. COPE is a voice for AFT Washington as we advocate for a stronger education system at all levels in Washington and for better working conditions for our members.

Lawmakers, whether on local school boards, in the state legislature, or in statewide offices, make decisions that affect our students' learning conditions and our members' wages, benefits and working conditions. Through COPE, we work to support candidates and that support our members.

COPE is not funded by member dues. We depend on voluntary contributions to fund this work, which includes:

- Drafting candidate questionnaires for the various offices and positions under consideration
- Evaluating completed candidate questionnaires Interviewing candidates
- Deciding on which candidates warrant endorsement and to which candidates we should make a campaign financial donation.

Unions play such a critical role in democracy at every level in our country, and COPE is where the bridge between AFT Washington members and our elected officials is built. Our members' contributions ensure that we're able to support policymakers



and hold them accountable. I'm excited about our legislative accomplishments over the past few years; they are the start of what we can achieve for our colleges and our communities.

Through AFT Washington's advocacy, Washington state legislators have:

- ► Established an 85% floor for adjunct faculty and required a plan to achieve this goal by 2027.
- Expanded collective bargaining laws allowing faculty to bargain for local dollars.
- Protected paraeducator jobs by requiring employers to honor paraeducators' experience.
- Created the Workforce Education Investment Account, an account solely meant for post-highschool education, through HB 2158.
- ► Fully funded I-732 COLAs and 4% COLAs for CTC pro staff.
- ▶ Funded paraeducator professional development.
- ► Gained tuition waivers for classified staff.
- Helped pass the Democracy Package, establishing:
 - » The Washington Voting Rights Act
 - » Automatic voter registration
 - » Same-day voter registration
 - » Postage-paid ballots
